Goal 5: Implement Information Technology Road Map

Goal 6: Plan, develop and implement an organization wide Asset Management Program Goal 7: Plan, develop and implement an organization wide Communication Plan and protocols

Goal 8: Develop and implement an organization wide Strategic Financial Plan

Assistant Finance Director Christina Haron and Budget Analyst Jamie Berger provided the Budget Committee with a PowerPoint presentation regarding the proposed budget for fiscal year 2024.

Items discussed were: County-wide Requirements; Capital Outlay; Other projects such as Transportation System Plan, Juniper Canyon Access, Compensation Plan Update;

Personnel FTE Changes; County-wide Resources; Property Taxes; Revenue: User Fee Increases; Revenue: New One-Time Federal Funds; Special Revenue Funds - Special Transportation Fund, Clerk Special Revenue Fund, Video Lottery Fund, Risk Management Fund, Surveyor Fund, Taylor Grazing Fund, Tourism Fund, Community College Education Center Fund, Crook County School Fund, and Title III Fund.
