The County has received numerous public records requests recently regarding the 2020 election. Many of these requestors are submitting similar requests to counties across the State.

One requestor, Debbie Rodgers, has requested the "cast vote record" also known as the "BP-033." My understanding of the document is that it tracks the voted/not voted status of voters without a reference to specific election choices.

Per the Clerk's fee schedule, Ms. Rodgers was quoted a fee of \$3.75 + \$0.40 per page of the report, which at 1,112 pages comes to a total \$448.55. Ms. Rodgers responded that the quoted fee was "completely unacceptable" and sent email correspondence from other counties (Yamhill, Jefferson, and Klamath) with fees for an identical request ranging from \$28 to \$39.46 asking me to reconsider the fee (see emails attached).

In response to Ms. Rodgers, I let her know that a fee reduction request would need to be approved by the County Court and would be based on whether the request benefits "the public interest because making the record available primarily benefits the general public." ORS 192.324(5). I then asked Ms. Rodgers to share why she felt her request met this standard. Her reply was that she is part of a few election teams (auditoregon.org, oregoniansforfairelections.com, and oregonpeoplesvote.com), and they are requesting this list from counties not already on file of national records at ordos.com.

Though more directed at public versus personal *use* (sharing with a national database) instead of articulating the benefit, Ms. Rodgers's justification could be viewed as meritorious. One could easily argue the public interest and benefit in fair and transparent elections as a cornerstone of democracy. One more note is that the County Clerk does not distinguish between printed and digital reports.
