Good afternoon Brent,

I hope the week has been treating you well. Thank you again for sharing Empire's updated EMR Plan. The plan itself is well written and has a lot a great information in it. The fire district will still need an official site plan to review for Oregon Fire Code access and water supply requirements. The bulk of this surrounds what they propose for interior access roads and whether they are proposing a perimeter road or not. The EMR plan focused on fires occurring in the structures or electrical components, but not a brush fire which is more likely going to be the issue.

We will also be requiring a onetime Impact Fee consistent with CCFR's Tax Exemption Policy. The fee schedule for this fee is \$1,000 per MW Capacity.
