### **Final Decision**

- Record Number 217-24-000198-PLNG: Conditional Use
  - Application to allow mining, crushing, and stockpiling of materials at the site, located at 7950 NW Lone Pine Road, Terrebonne, OR, adjacent to an existing 9-acre permitted area. The property is zoned Exclusive Farm Use (EFU2). The Board of County Commissioners approved adding the site to the Comprehensive Plan Goal 5 aggregate resource list; this continuation is for deliberations only on the conditional use proposal.

## Public Hearing

- Record Number 217-25-000034-PLNG Zone Map Amendment
  - Lester Revocable Trust, Andrew and Shannon Lester (Owner/s) propose to amend the Crook County Zoning Map ("Zoning Map") to change the zoning of Tax Lot No. 1614110000601 from Exclusive Farm Use zone, EFU-3 (Powell Butte area) to Rural Residential 10, R-10. The situs address is 11404 SW Reif Rd, Powell Butte. The property is located approximately 3 miles south of Highway 126, in Powell Butte.
- Record Number 217-24-000293-PLNG: Conditional Use
  - Proposal for a photovoltaic (pv) solar power generation facility located on property zoned Exclusive Farm Use zone, EFU-3. The proposal includes a ground mounted solar array, gen tie transmission lines, a substation, an energy storage system, and an operation and maintenance facility. The project is proposed to be a 320-acre site, on a portion of property identified as map tax lot: 161500000300. It is north of an existing solar facility.
