**Record Number 217-25-000081-PLNG:** Conditional Use. Weston's Rock Ridge Ranch LLC and Philip Weston (Owner/Applicant) request a conditional use for a private use airstrip. The proposed private airstrip would be located at 7837 NW Lone Pine Ln, Terrebonne, identified as 1414070000203. The hearing is being held pursuant to Crook County Code (CCC) 18.172 Administration Provisions. The application is subject to review under CCC, Title 18, Chapter 16, Chapter 160, the Crook County Comprehensive Plan, Oregon Administrative Rules, and Oregon Revised Statutes.

A notice of public hearing and location maps are being mailed to all affected property owners, and to the appropriate entities and public agencies at least 20 days prior to the Planning Commission hearing.
